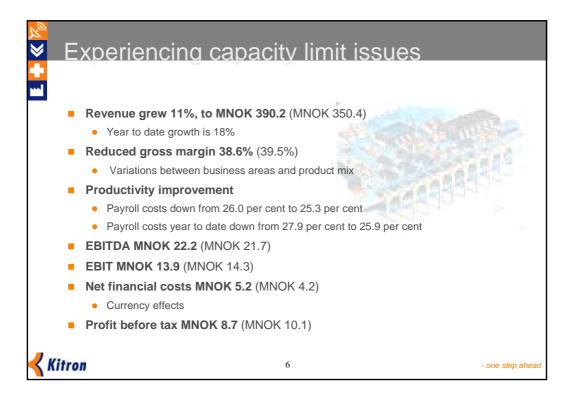

Expects deliveries of about NOK 150 million during 2007-2008 (reported as after Q2 event in Q2 presentation) Structural changes and increased capacity Kitron acquired and integrated EDC Elsis UAB in Kaunas, Lithuania Relocation of Kitron Flen activities according to plan • Insignificant costs to date 3/4 of revenue retained • Expansion in Kaunas, Lithuania • On stream in 2009 Revenue more than NOK 500 million • per year at full capacity Kitron 4 - one step ahead

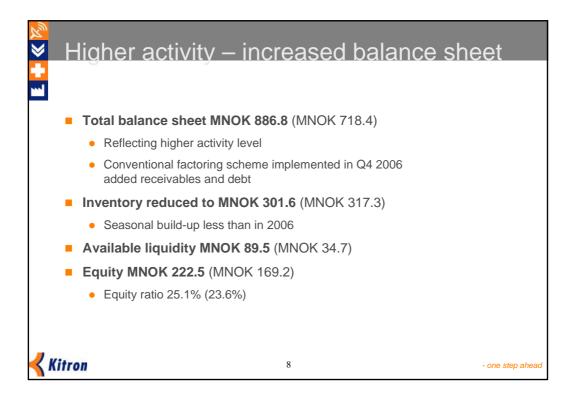

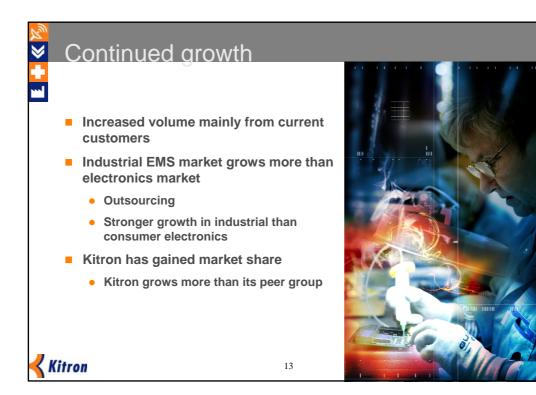
