All items with limited durability must be delivered to Kitron with a minimum of 75% remaining durability period. Where applicable a MSDS (Material Safety Data Sheet) must be obtainable upon request and provided with any future order to Kitron.

General requirements:

- Accept that any purchase order from Kitron AS may be subject to GQA (Government Quality Assurance). You will be notified of any GQA activity to be performed.
- Ensure that ESD sensitive components must be packed in accordance with Standard IEC 61340-5-1.
- Ensure that moisture sensitive components (classified by IPC/JEDEC J-STD-020 or equal) are handled according to IPC/JEDEC J-STD-033 or equal.

- Unless otherwise specified in the actual purchase order, the total quantity shall be delivered in one delivery. If the order specifies a number of deliveries and quantities, these shall be strictly adhered to.
